SUBJECT: **ASCIP-B 2025-26 Program for Boosters & Foundations**

ASCIP is pleased to continue offering the ASCIP-B program to members. The program provides general liability coverage for booster clubs, auxiliary organizations, non-parent and parent-run foundations, and parent-teacher organizations that support the member district's educational and extracurricular programs.

This policy is separate from the ASCIP Memorandum of Coverage (MOC), as these organizations are typically not controlled by the District and are therefore excluded from the MOC. We recognize these organizations are vital to districts for their fundraising efforts; thus, we continue to offer this program to our members. By offering this program, organizations provide a viable option for obtaining general liability coverage, allowing members to have peace of mind knowing that these organizations maintain liability coverage throughout the year. Please note that the ASCIP-B program only provides general liability coverage and not liability or workers' compensation coverage.
